KNOW ALL MEN BY THESE PRESENTS, that the undersigned in order to establish a non-profit corporation pursuant to the Colorado Non-profit Corporation Act hereby certifies:

ARTICLE I.

### Name

The name of the corporation shall be:

SUNSHINE CONDOMINIUMS ASSOCIATION

APTICLE II.

## Duration

The corporation shall have perpetual existence.

ARTICLE III.

## Purposes

The corporation is established not for profit and its objects and purposes are.

- 1. To covern the condominium property situate in the County of Gunrison, State of Colorado, which is termed Sunshine Condominiums.
- 2. To constitute the association to which reference is made in the Condominium Declaration for Sunshine Condominiums and to perform all of the rights, duties and obligations and to exercise all of the powers as specified in said Condominium Declaration.

ARTICLE IV.

## Powers

The corporation shall have and may exercise all powers conferred upon non-profit corporations organized and existing under the laws of the State of Colorado.

# ARTICLE V.

# Members

- 1. The owner of a condominium unit in Sunshine Condominiums, upon becoming such owner, shall be entitled and required to be a member of the corporation and shall remain a member of the corporation for the period of ownership of a condominium unit.
- the terms and conditions of membership shall be as not forth in the Articles and Bylaws of this Corporation and the Condominium Declaration of Sunshine Condominiums.
- 3. There shall be one class of members. The corporation may issue a certificate evidencing membership therein.

## Board of Managers

- 1. The affairs of the corporation shall be managed by a board of managers.
- 2. The board of managers shall consist of not less than three nor more than five members, the numbers of managers, their term of office and the manner of their election shall be as set torth in the sylaws of the corporation.
